What is the overall <a href="#">deductible</a> ?	<p><b>In-Network:</b> \$3,500 individual / \$7,000 family.</p> <p><b>Out-of-Network:</b> \$7,000 individual / \$14,000 family</p>	<p>Generally, you must pay all the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a>, each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a>.</p>
Are there services covered before you meet your <a href="#">deductible</a> ?	<p>Yes. <a href="#">Preventive care</a> is covered before you meet your <a href="#">deductible</a>.</p>	<p>This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. For example, this <a href="#">plan</a> covers certain <a href="#">preventive services</a> without <a href="#">cost-sharing</a> and before you meet your <a href="#">deductible</a>. What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	<p>For participating <a href="#">providers</a> \$7,900 individual / \$15,800 family. For non-participating <a href="#">providers</a> \$15,800 individual / \$31,600 family</p>	<p>The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services. If you have other family members in this <a href="#">plan</a>, they have to meet their own <a href="#">out-of-pocket limits</a> until the overall family <a href="#">out-of-pocket limit</a> has been met.</p>
What is not included in the <a href="#">out-of-pocket limit</a> ?	<p><a href="#">Premiums</a>, <a href="#">balance-billing</a> charges, and health care this <a href="#">plan</a> doesn't cover.</p>	<p>Even though you pay these expenses, they don't count toward the <a href="#">out-of-pocket limit</a>.</p>
Will you pay less if you use a <a href="#">network provider</a> ?	<p>Yes. ### Does this plan provide Minimum Essential Coverage? Yes.

## About these Coverage Examples
